## IBEW LU 278 Scholarship Funded by Scott Electric Company

This scholarship was established by Scott Electric Company to assist the families of members of the International Brotherhood of Electrical Workers Local Union #278 with funding for their higher education. The five \$4,000 scholarships awarded annually are for incoming or current students of Texas A&M University- Corpus Christi who have good potential, as well as a financial need. Applicants must be the children, stepchildren, or grandchildren of members of IBEW LU 278. Recipients must maintain a GPA of 3.0 on a 4.0 scale and full time status (12 semester credits) while in college. Recipients may re-apply for up to 3 additional years, but will compete with other applicants.

### Guidelines and Instructions:

To be considered for an IBEW LU 278 an applicant must:

1. Be a child, stepchild, or grandchild or spouse of an IBEW Local Union #278 member.
2. Have potential and show a financial need.
3. Have a cumulative high school GPA of 3.0 on a 4.0 scale.
4. Enroll as a full time college student (at least 12 semester credits) and maintain a GPA of 3.0 points on a 4.0 point scale.
5. Submit the following in one envelope:
  - Completed application form.
  - An official high school transcript though fall semester of senior year.
  - The most recent college transcript, if available.
  - A dues receipt from a member of IBEW LU 278 dated within a year of application date.
  - FAFSA 05-06
